1. Gini bụ pénshonu?

2. Gini bụ Micro Pension Plan?

Micro Pension Plan bụ nhàzí dí n'okpuru Atumatu Ntukota Penshonu (Contributory Pension Scheme - CPS) nke na-ekwe ka ndị nọ n'orụ nrūrúo nwe ma ọ bụ ndị na-arụ n'uloorụ nwere ndị-orụ na-érughị ato na-àtukótá ego maka mwube penshonu nke ha n'oge ezumike nka ha ma ọ bụ n'oge ha agaghị ènwézí ike ịrụ ọru.

3. Gini ka ọ ga-eji bürü Micro Pension?

5. Atumatụ Ntukọta Penshọnụ (Contributory Pension Scheme - CPS) a manyere n'iwu ọ dị iche na Micro Pension Plan?

Penshọnụ a manyere n'iwu nakwa Micro Pension Plan bụ nhazi dị n'okpuru Atumatụ Ntukọta Penshọnụ (Contributory Pension Scheme - CPS). Naanị ihe dị iche n'etiti ha abụo bụ ụdị ndị na-eme ha.
