2. Gịnị bụ Micro Pension Plan?

Micro Pension Plan bụ nhàzị dị n'okpuru Atumatu Ntụkọta Penshonu (Contributory Pension Scheme - CPS) nke na-ekwe ka ndị nọ n'ọrụ nrụrụo nwe ma ọ bụ ndị na-arụ n'ụlọọrụ nwere ndị-ọrụ na-érughị atọ na-àtúkótá ego maka mwube penshonu nke ha n'oge ezumike nka ha ma ọ bụ n'oge ha agaghị ènwézi ike iru ọrụ.

Ndị nlekọta ego ezumike nka (Pension Fund Administrator - PFA) na-ejikwa ma na-etinyekwa ego atụtọtara n'okpuru Micro Pension Plan n'orụ, na nnọchite anya nke onye ntụtọtaego, ebe ndị njikọta ego ezumike nka (Pension Fund Custodian) na-edebe ya bụ ego na akụ n'ezi nchekwa.
